

This off-limits order prohibits military personnel from entering the above establishments, to include the adjoining parking lots until further notice. Any military member who violates this order may be subject to disciplinary action under the Uniform Code of Military Justice.

I have placed these establishments off-limits due to recent criminal activity in these establishments that in my judgment have endangered the good order, discipline, health, morale, safety and welfare of Sheppard Air Force Base military personnel. This order is made pursuant to AFI 31-213, *Armed Forces Disciplinary Control Boards and Off-Installation Liaison and Operations*, 27 July 2006, paragraph 2-6.a.
